Hillary on Reproductive Health and Justice

Her strong stance on reproductive rights is a reflection of her dedication to the women and girls of this country and around the world. Clinton strongly opposes the Hyde Amendment, which bans the use of federal funds for abortion services, and has promised that overturning the global gag rule will be one of her first acts as President. Eliminating the global gag rule will ensure that women around the world will have the education and opportunity to make important decisions about their reproductive health.

While in the Senate, Hillary Clinton had perfect voting records in support of women's health and reproductive rights. Her political record is crystal clear: she is here for women and she will fight for our rights.

Hillary Clinton	Donald Trump
Reproductive Rights	
Clinton has called for the repeal of the Hyde Amendment, a piece of legislature that prevents the use of federal funds for abortion.	Wants to ban abortion after 20 weeks, with exceptions only for rape, incest, or when the life of the women is in danger.
Clinton introduced 8 pieces of legislation with the clear purpose of expanding and protecting women’s access to reproductive health care.	Has promised to nominate conservative Supreme Court justices that will overturn Roe v. Wade
Clinton consistently co-sponsored and voted for pro-women’s health legislation while in the Senate.	Trump only wants to allow abortion access in cases of rape, incest, and “if the mother is close to death.”
Birth Control	
Clinton waged a multiyear effort to pass a breakthrough in birth control access that made emergency contraception available over the counter.	Like most of his positions on policy, Trump’s views on contraception and family planning are unclear. What we do know is that Trump says he’ll repeal the Affordable Care Act– a piece of legislation that has enabled millions of people to get health insurance that covers birth control at no additional cost.
Clinton helped launch the National Campaign to Prevent Teen and Unplanned Pregnancy, which supports access to birth control, family planning, and sex education.	
As senator, Hillary boldly defended access to emergency contraception and fought against a bill that would qualify an IUD as an abortive device.	
She has strongly and publicly criticized the Supreme Court’s ruling in <i>Burwell v. Hobby Lobby</i> that allows family-owned corporations to deny their employees contraceptives that are otherwise required under the ACA.	
Trump promises that the Hobby Lobby ruling will be used as a “litmus test” for future federal court appointees: if they don’t agree that CEOs can stop their female employees from accessing contraceptives, they won’t be appointed under President Trump.	
International Reproductive Health Access	
As senator, Clinton introduced the legislation to restore funding to the UN Population Fund (UNFPA) and restored it after the Bush administration as Secretary of State. UNFPA recognizes family planning and sexual health as a human right and fights for that right on the global scale.	Surprise, surprise: not only has Donald Trump not done anything to help women around the world, he has not taken a stance on global health access.
