

We will be electing National NOW officers at this year's national conference in Las Vegas Nevada. We will elect a President and a Vice President. Per NOW bylaws the officers must run as a ticket. Nominations for officer tickets shall be submitted to the Nominating Committee in writing at least 90 days before the election Conference. Each officer ticket submitted to the Committee must contain a nomination for every officer position. Nominations shall not be taken from the floor.

DUTIES OF NOW OFFICERS

The National Officers shall constitute the Executive Committee and are mandated to exercise their fiduciary duty to the organization and the membership. The National Officers may delegate such duties as may be necessary to allow them to implement the performance of their office, but they may not delegate their responsibility.

DUTIES OF THE PRESIDENT

There shall be a President who shall be compensated and shall be a voting member of the National Board. The President shall be the principal spokesperson and chief executive and financial officer of the organization, shall call the meetings of the Board, the Executive Committee, and the National Conference and shall preside at these meetings. The President is tasked with, overseeing the Operations Manager, who is in turn in charge of the administration of the National Action Center and creating the Organization's budget, with the advice of the Finance and Budget Committee and the President, for approval by the National Board. The President shall also serve as the Chair of the NOW PAC.

DUTIES of the Vice President

There shall be a Vice President who shall be compensated and shall be a voting member of the National Board. The Vice President shall preside at all meetings in the absence of the President, keep the minutes of the meetings of the Board, the Executive Committee and National Conference, be custodian of the records, and perform such other duties as may be delegated by the President and Board. For corporate purposes, the Vice President shall be designated Secretary/Treasurer. The Vice President shall serve as the Treasurer of the NOW PAC.

ELIGIBILITY REQUIREMENTS

- All national officers shall have been members of NOW for at least four years immediately prior to election and shall have served at least two years as a chapter or state officer or National Board member. Each term of office shall be four years and shall begin 30 days following the election at the National Conference. Each officer shall serve no more than two consecutive terms.
- In the case of officers appointed to fill a vacancy under Article XII, their partial terms shall not be considered in determining the term limitation.

ELECTION DATE AND LOCATION

The election will take place during the 2025 [National NOW Conference](#) (July 11-13) at the Saharra in Las Vegas Nevada.

HOW TO APPLY

If you are interested in running for National NOW Officer, you must submit your ticket information via this [online form](#) by 11:59 PM (Eastern Standard Time), April 12, 2025. (We realize this is Passover; however, our bylaws require a 90-day deadline that falls on the 12th.) Those members who complete the form and are verified as eligible to run for National NOW Office will have their nomination information shared via the NOW website and through email in advance of the officer elections.

The Nominating Committee, will work with the National Action Center to verify every candidate's eligibility for office. The members of the Nominating Committee shall be appointed by the district representatives in each District with recommendation from chapter leaders and members in the district.
